Perch Base Minutes July 9, 2016

OFFICERS REPORTS

ASSM – Dan Moss

Dan gave a report on the progress of the memorial. He also mentioned how he was on the radio last month, and an article was in today's paper in regards to the memorial. There is a Go Fund Me account set up also.

Communications Officer/Historian – Chuck Luna

Chuck Luna reported that the latest Midwatch was sent out last week. He encouraged everyone to send pictures or stories to be included in the Fall Quarterly Midwatch. Deadline for items is Sept. 16, 2016.

COB – Richard Kunze

Richard had nothing to report.

Treasurer – Dave Heighway

Dave mentioned that we now have a credit card reader that can accept the new chip credit cards. Credit cards can be used for purchasing or pre-ordering items from the Storekeeper or renewing dues.

Credit cards can only be used at a meeting when the reader is present. No telephone or mail credit card orders through the base.

Storekeeper – Herb Herman

Herb has many items for sale in the back of the room. He mentioned that if anyone needs patches or challenge coins for the convention next month, to let him know. He also mentioned that Holly Walker, our vest lady, is at the meeting today.

Webmaster – Dan Marks

Dan mentioned that Gov. Ducey announced that all flags fly at half mast, until Tues., July 12, 2016, in memory of the Dallas Police who lost their lives this past week.

There have been numerous updates, but no major changes to the website during the past month; simply updating pages such as the Sailing Orders, adding notices and/or photo pages such as the Michael Mattered Eternal Patrol obituary, the Dan Moss interview on KFAX Radio, the Base Birthday on June 20th, several half-staff notices, details for the Sunfish Reunion, and several notices regarding voting.

Photos have been posted for the Prescott Frontier Days rodeo parade, but none for the BBQ. I will ask at the next Base meeting if anyone has photos from the BBQ.

During June, there were approximately 1,535 page views on the Perch Base website during 692 sessions by 508 users based on Google Analytics. Approximately 75% of the sessions originated in the US, 2% each from Brazil, the United Kingdom, and Japan. The remaining 19% are widely scattered around the world. Approximately 33% of the sessions were from locations within Arizona. The Homepage accounted for the largest (38%) percentage of the page views this month, exceeding the Glossary (28%), the Sailing Orders page (10%), and the Eternal Patrol page (3%).

Membership – Jim Andrews

Jim reported that we had a total of 168 members attached to Perch Base and USSVI. Today, two new members signed up, bringing our total to 170. He also encouraged members to use the credit card system that's now in place, for membership dues.

Events Coordinator – Don Unser

Don mentioned how well received we were at the Prescott Parade and encouraged more members to be a part of the parades where our float is involved.
