



## **July Meeting Minutes**

The regular monthly meeting of the Arizona Submarine Veterans B Perch Base was convened at American Legion Post #62 Peoria, AZ at 1300 hours, 8 May 2004. The meeting was called to order by the Base Commander – Glenn Herold.

Base Chaplain Howard Doyle led the members in a prayer of Invocation. The members were then led in the "Pledge of Allegiance" followed by a reading of the "Purpose of the Organization", Dedication, a Moment of Silence for our departed shipmates and the "Tolling of the Boats @ ceremony for submarines lost during the month of July.

According to the sailing list, there were 25 members and 1 guest at the meeting. Those present welcomed our guest and new member— Shipmates Kirby Anderson and Jack Messersmith. Kirby is a new member from Williams, Arizona and Jack is a Member at Large from Prescott. Kirby

and Jack introduced themselves and gave the members a brief description of their submarine experiences. They were then given a resounding welcome from the members.

#### The Final Patrol


Lord, this departed shipmate with dolphins on his chest is part of an outfit known as the best.

## U.S.S. Grunion (SS-216) 70 men lost



The submarine GRUNION arrived at Pearl Harbor on 20 June 1942, reporting for duty from the West Coast. This vessel engaged in the pre-patrol training given to all submarines reporting from new construction yards, and on 30 June, left for patrol.

Lt. Cmdr. Mannert L. Abele, in command, was ordered to proceed to the Aleutian Theater and patrol westward from Attu on routes between the Aleutians and the Japanese Empire. On 10 July GRUNION was reassigned to the area north of Kiska. GRUNION made her first report on 15 July: Dutch Harbor received her message that she was attacked by an enemy destroyer; she had fired three torpedoes at it, and missed with all.

Shortly after this message was received GRUNION sent another relating that she had sunk three destroyer-type vessels on 15 July. This message was garbled to the extent that details of the attacks were never learned (Japanese information reveals that GRUNION sank patrol boats 25 and 27 and damaged a third patrol vessel). On 19 July GRUNION, S-32, TRITON and TUNA were assigned areas in the approaches to Kiska, all to be there by daylight 22 July.

There was a strong concentration of enemy vessels at Kiska, this time being only a month and a half after the enemy had taken that island. The vessels patrolling there were told to

watch particularly on the afternoon of 22 July 1942 for departing enemy naval vessels, since our own surface forces were scheduled to bombard Kiska that afternoon. The bombardment did not take place in accordance with the original plans, but our forces did stage the operation on 28 July and GRUNION was told to guard the exits from Kiska during darkness on this date. On this day GRUNION reported an attack on unidentified enemy ships six miles southeast of Sirius Point, Kiska. She had fired two torpedoes, made no hits, and been depth charged, but sustained no damage.

GRUNION's last transmission was received 30 July 1942. She reported heavy antisubmarine activity at the entrance to Kiska, and that she had ten torpedoes remaining. On the same day, GRUNION was directed to return to Dutch Harbor. She was not contacted or sighted after 30 July, despite every effort to do so, and on 16 August was reported lost. Planes observing the approaches to Kiska for indications of enemy salvage operations in connection with GRUNION reported negatively.

Japanese antisubmarine attack data available now record no attack in the Aleutian area at this time, and GRUNION's fate remains an unsolved mystery. We know of no enemy minefields which were in her area; thus her loss may be presumed to have been operational or as a result of an unrecorded enemy attack.

**UPDATE** - A gentleman in Japan, Yutaka Iwasaki, posted some interesting information on his website, about sunken Japanese ships during WWII, which includes information about the possible fate of the USS GRUNION.


The Kano Maru was sunk at Kiska. Mr. Iwasaki kindly provided some very interesting information about the ship's history and the USS GRUNION. He provided the following on the history of the ship in connection to the loss of the GRUNION (publications S.Komamiya's Wartime ship history (1991 private issue) and JIRO Kimata's Submarine attack" (2000 Kojin-Sya)):

#### Kano Maru

- 30 July, 1942 08:00 Arrived at 36km north of Kiska. Heavy fog prevented approach, lost contact with the escort, forced drifting. Getting location by astronomical, she restarted approach to Kiska with 15kt.
- 31 July, 1942 05:47 Torpedoed by Submarine Grunion (SS-216). One hit at machinery room starboard, main engine and generator stopped. No more escape nor radio (sic).
- 31 July, 1942 05:57 Second torpedo came, but passed below the ship. Kano Maru pretended to

launch seaplane without pilot, failed to start propeller.

31 July, 1942 - 06:07 Third and fourth torpedo came, hit fore bridge and amidships on the port but both dud. The Grunion intended to surface and sink by gunfire, ripples was seen 400m distance from her. Kano Maru had two old 8cm guns on forecastle and stern. Stern's one malfunction by the torpedo shock, but forecastle gun fired to the periscope. 13mm machine guns on bridge fired as well. Before the sub appear the whole, fourth shot from Kano Maru hit the conning tower of the sub. It is thought the last of Grunion. The attack had ceased. Later rescue came from Kiska, three seaplanes, cable layer Ukishima, and sub chaser No. 26:

## USS Virginia (SSN-774) Passes First At Sea Test

WASHINGTON (NNS) — Completing one of the first significant events in the Navy's newest submarine class, PCU Virginia (SSN 774) returned to New London, Conn., July 30 after putting the ship's propulsion plant through its most strenuous test yet.

Virginia's initial (or Alpha) sea trials also gave the builders and crew a chance to test the watertight integrity of the ship and to examine major systems, such as the ship's steering and diving, hydraulics and Emergency Main



Ballast Tank Blow System. The three-day trip included evaluating the clearance and watertightness of external and internal hatches and hull fittings, while incrementally taking the ship to test depth. This also allowed the ship to discover any potential rattles or unwanted sounds caused by the compression of the submarine due to the ocean's pressure on the hull.

This test, the first of many before Virginia's initial scheduled deployment, was the chance to put to sea the Navy's first post-Cold War submarine, one designed from blueprint to reality with long-term technological innovation in mind. The submarine boasts multimission capability and will include advanced heavyweight torpedoes, mines and Unmanned Undersea Vehicles (UUVs). In addition, Tomahawk missiles will be carried in vertical launch tubes, and it will feature an integral lock-out/lock-in chamber for

Special Operations Forces and the ability to carry the Advanced Seal Delivery System (ASDS).

"We don't know who the next conflict will be against, but the Virginia SSN has the versatility to deal with any foe, whether in a cave hundreds of miles inland, on a freighter smuggling WMDs [weapons of mass destruction], or a navy with a credible submarine or surface force," said Capt. Dale Nees, the branch head for Submarine Acquisition, Refueling Overhauls, SSBN and SSGN Programs within the Submarine Warfare Division (N77) of the OPNAV staff. "The SSN, with its persistent, clandestine, non-provocative capabilities, provides the President and the joint forces commander with options to execute our national and military strategy."

Nees said many tests on the propulsion plant and other ship's systems on Virginia were already done while the ship was in New London.

"But you're talking about a big hunk of steel, welded up on dry land, and filled with complicated and sophisticated equipment," Nees said. "You have to take it out to sea to find out if it all works as intended."

With much of the design work on Virginia completed through a first-time use of state-of-the-art computer modeling, the Alpha sea trials also offered the first chance to test systems such as the real-world hydrodynamic

effects of the rudder and planes against the design parameters.

In addition to testing the submarine's equipment, the crew of Virginia has been looking forward to the first chance to take the lead ship of this class to sea.

"For a few years now, this crew has been an integral part of the incremental process of completing assembly, testing, quality assurance and the paperwork leading up to the operation of the ship and its systems," Nees said. "These guys are Sailors first, and like all Sailors, they are anxious to get back to sea."

The efforts of the plankowners of Virginia have been an important part of the success in delivering the ship, Nees added.

"This crew has one of the more demanding jobs in the submarine force. Not only do they have the responsibility of supporting the building of a new ship, but they've also been spending countless hours in trainers, classrooms, and many of them have been out on other ships to get or to stay qualified," Nees said. "So not only are they finishing up the transition from shore-based maintenance to a ship ready for sea, they're also standing watches, performing all the routine maintenance, admin, housekeeping, etc., as well. I'm sure they're very excited to put the ship to sea."

Nees also pointed out that the sooner Virginia can get to sea and deliver, the more money the government saves.

But Nees compared construction on Virginia favorably to previous first-of-a-class submarine construction programs. For example, the projected man-hours to complete Virginia are about two-thirds of those for the Ohio and Seawolf class submarines, and only exceed original estimates by about 20 percent, as compared to nearly 80 percent for Seawolf and 65 percent for Ohio. Further, Virginia will be delivered three to four months later than planned, based on an original schedule estimated six years ago; by comparison, the Seawolf was 25 months late; Los Angeles was 26 months behind schedule; and Ohio was 30 months overdue.

"We're not pleased with the cost growth, and continue to look at this carefully, but we are much closer in estimating production man-hours, and we're doing a better job on design efforts," Nees added.

As Virginia begins operations outside the shipyard, the focus will shift away from the cost of the new class

toward the capabilities of this formidable addition to the nation's defense arsenal.

The next test for Virginia will be Bravo sea trials in August, Nees said, with particular attention to the ship's underwater acoustics. Afterward, the ship will pull into Norfolk in time for preparations for the submarine's commissioning ceremony Oct. 23.



Virginia will return to New London after the ceremony to enter a yearlong post-delivery trial period. During this period, Nees said, tests will "run the full gamut; sound trials, fire control, sonar, communications, weapon launchers, you name it, every system evaluated in excruciating detail - especially since this is the lead ship of the class. We'll use this as an opportunity to evaluate whether we need to make any changes in construction, to discover whether we have any design problems that need to be resolved."

Post-availability shakedown is scheduled to begin in the fall of 2005, and the submarine force leadership is striving for an accelerated schedule to deploy Virginia as soon as possible.

I have felt for a long time that much has been written about the sagas, etc. of the boats but little about our actual life on board on a day to day basis. Consequently, I wrote this article for the benefit of the members of my Central Ct. Chapter US SubVets WWII and apparently it has gotten wide, and favorable, distribution.

Your PERCH base mention lets me recall a story. Shortly after the war we got a new Skipper on the USS TRUMPETFISH (SS425). His name was K.G. Schacht. He spent the entire war in a Jap POW camp. He was taken prisoner off the Perch in March of 1942. He went into POW camp as a LTJG and was (as were all POW's) promoted as if he spent all that time on active duty and came out a full Commander in late 1945. At first the Exec really ran the boat as he acclimated himself and learned the ropes. He was, without question, the best Skipper that I ever had in over 20 years. There are a few of us still alive that served together on that boat, we all still correspond and all still remember him most fondly. He eventually retired as a Rear Admiral and is now deceased.

While he was a POW his wife divorced him; that coupled with the fact that all his classmates at the Academy had had their commands and he had to catch up on his career and life made the TRUMPETFISH a boat for single sailors only. Including the Skipper it was one hell raising experience for all hands no matter what port we went into.


