

# LEST WE FORGET THOSE STILL ON PATROL

**JULY ETERNAL PATROLS** 



**July 30, 1919 USS G-2(SS-27) 3 men lost** Sank during an inspection by a maintenance crew near Niantic Bay.

**July 30, 1942 USS Grunion(SS-216) 70 men lost** Lost off Kiska, AK -- presumed by enemy action -- but officially "overdue and presumed lost." The final location was found and verified in 2008 but actual cause of her loss is still unknown. (Note: Sunk by armed Japanese freighter Kano Maru)





July 4, 1944 USS S-28 (SS-133) 49 men lost

Following a Hawaii overhaul S-28, on 3 July 1944, began training operations off Oahu. The antisubmarine warfare exercises continued into the evening of 4 July. As evening began contact between her and surface ships became sporadic and, at 18:20, the last, brief contact with S-28 was made and lost. All attempts to establish communications failed and a thorough search of the area failed to locate the submarine. A Court of Inquiry was unable to determine the cause of the loss of S-28.

July 26, 1944 USS Robalo(SS-273) 81 men lost From a POW's note, it was concluded Robalo was sunk on 26 July 1944, 2 mi off the coast of Palawan Island from an explosion in the vicinity of her after battery, probably caused by an enemy mine. There were four survivors captured but they did not survive the war. Robalo was stricken from the Naval Vessel Register on 16 September 1944.

OUR PERCH BASE CONSTITUTION AND BYLAWS REQUIRES THAT ANY CHANGES TO THAT DOCUMENT MUST BE POSTED IN THE MIDWATCH FOR TWO (2) MONTHS PRIOR TO A VOTE TAKEN BY THE BASE. THE BOARD OF DIRECTORS HAS PROPOSED THE FOLLOW CHANGES AS INDICATED BY THE YELLOW HIGHLIGHTING. IN ALL CASES, THE CHANGES ARE EITHER REQUIRED BY THE NATIONAL CONSTITUTION OR ARE EDITORIAL CHANGES.

### Proposed Amendment to the Perch Base Constitution and Bylaws.

The following changes are proposed to bring our Constitution and Bylaws into better compliance with the USSVI Constitution and Bylaws.

#### **Various Locations**

The term "Submariners" is used in the title of the organization in place of the misleading "Submarine Veterans, Inc."

### Article VII - Membership, Section 3 Associate Membership

Change paragraph 1 to read "Associate Membership is reserved for persons not otherwise eligible for regular membership. Details on Associate Membership shall be as defined in, and controlled by, the USSVI Perch Base Policies and Procedures Manual, (Latest edition.)

Delete the rest of Section 3

Justification: The details on Associate membership belong in the document that details the other activities of Perch Base. The Constitution and Bylaws provide an overview of activities not the details.

### Article VII - Membership, Section 6 Honorary Members

Add to paragraph 1 "The Board of Directors must vote in the majority to approve this action.

Justification: Prudent action for the position.

### Article VIII - Membership Dues, Section 4 New Member Dues

Add to the end of the paragraph "as defined in the USSVI Perch Base Policies and Procedures Manual, (Latest edition.)

Justification: Consistency with similar statements throughout the document.

### Article IX - Officers, Section 2 Appointed Officers

Add Membership Chairman to the list.

Justification: Consistency, the Membership Chairman position is an appointed officer in the Policies and Procedures Manual

### Article XVI - Amendments, Section 2 Approval

Add to the first sentence of paragraph 1. "...for the good of the Base and to ensure the amendment does not conflict with the National Constitution or Bylaws."

Justification: Required by the National Constitution.

### Article XVI – Amendments, Section 3 Effective Date

Change to read

Amendments which are passed shall be sent to the District Commander for approval and will then become effective upon publication of the final document in the MidWatch.

Justification: Required by the National Constitution.



The "Call to Order" was led in a prayer of invocation by Base Chaplain Steve Leon followed by the Pledge of Allegiance and the standard ceremonial opening. The tolling ceremony was conducted for all boats lost in the month of June and a moment of silence was observed for our shipmates on eternal patrol.

Rick Simmons stated we had three new members join this month and one was present, Mark Field. The two new members who weren't present are currently on active duty. One is Jerry Pittman, Jr., son of Jerry Pittman and he is a Ltig on the USS Cheyenne SSN-773 and the other is Juan Amaya who is a MM2 serving on board the USS Jefferson City SSN-759 and he is Jerry Pittman's nephew. ### Base Commander's Board of Directors Meeting Report

The Annual Picnic was held on 11 May 2013 and there were some 65 people in attendance. A good time was had by but it was noted that we could have used one more container of potato salad for this number of attendees. Howard said that if anyone had any suggestions on how we might improve the picnic for next year to let him know. There were Holland Club Induction Ceremonies held for both Gudgeon and Tautog Bases.

On Saturday the 18th of May we attended the Armed Forces Day event in Flagstaff and it was a success. Tucson Base also brought their float up for this event. We had 7 members and 2 wives in attendance and it was mentioned that this was the 7<sup>th</sup> year they have had the parade and the 7<sup>th</sup> year that Perch Base has participated in this event. The event planners were very appreciative or our participation in their event and we were also very well received by the crowd.

On the 27th of May we attended the annual Memorial Day Ceremony at the National Cemetery and we presented wreaths for both the WWII submarine veterans and Perch Base. Following the main ceremony we conducted a tolling ceremony narrated by Chuck Emmett for all lost U.S. submarines. It was a good turnout and Howard suggested that if you have not attended in the past, you are encouraged to attend in the future. He went on to say that this is probably the primary event for submarine veterans and Perch Base.

We are going to have an election for District Commander WD1. Jack Messersmith from Gudgeon Base is the current District Commander and his term will be expiring with the upcoming national convention. Currently we have one candidate for District Commander WD1 and that is Jim Denzien. A Flash Traffic will be sent out too all hands with a ballot with Jim's name and a place for write-in nominees as well. These ballots need to be returned to Howard electronically by the end of June. Paper ballots will be sent out to those members who do not have e-mail. We want to encourage all members to vote to show support for this election.

Herb Herman is currently dealing with some medical issues and is in Good Samaritan Hospital. Family members are the only ones who have visitation at this time. Chuck will keep us updated on Herb's condition as he receives information. During Herb's absence, Tim Moore will act as Interim Secretary.

The Board of Directors voted to send \$1.00 per member, for a total of \$153.00, to the USSVI for the support of the National Holland Club. They solicited the bases to consider donating \$1.00 for each Holland Club member they have. The Board of Directors decided that since we will all eventually be Holland Club members that we would donate \$1.00 for each Perch Base member and a check has been issued.

#### Officers and Committee Chairmen

**Vice-Commander/Communications Officer** – Chuck Emmett mentioned there has been some confusion about the deadline for submission of articles for the MidWatch. It is a "fixed' time and all articles need to be submitted no later than 8:00 am on the 3<sup>rd</sup> Friday preceding the base meeting that is 3 Fridays before the monthly meeting. There will be a box on the right side of webpage that notes the deadline date. There will also be a box or link, on the left webpage that you can click on to view pictures of the most current event. You will be able to click on a directory of the last events and then click on the event you wish to view.

Chuck also brought up the issue of when it is appropriate or not appropriate for veterans to salute or not salute when the flag passes in review or we hear the National Anthem. Recently legislation has been passed addressing this issue. Jim Denzien will look into what is the correct protocol and let Chuck know and this information will be published in a future newsletter article.

Interim Secretary - Tim Moore had nothing to report.

**Treasurer** – Bob Warner was not present.

Membership Chair - Rick reported that there were no changes in the membership which currently stands at 153.

**Chaplain –** Steve Leon stated that Angie Gram (Joe Varese's daughter) and her husband are ardent supporters of Perch Base and what we do. Steve recommended that we offer her an Associate Member position. Each Perch Base member can sponsor one Associate Member and Steve has used his sponsorship. Steve has offered to pay for Angie's dues for the first year and Doug LaRock volunteered to be her base sponsor.

**Events Coordinator** – Walt Blomgren mentioned the only upcoming event is the Prescott Frontier Days 4<sup>th</sup> of July Parade which will be held on Saturday, July 6<sup>th</sup>. Walt said as soon as he gets the particulars he will send out a Flash Traffic with the necessary updates. Howard added that anyone who wants to go up the day before (Friday the 5<sup>th</sup>) should give their name(s) to him and he will try to make reservations. George Crider will be bringing his trailer so there will be plenty of room for people to ride in this parade. There was also discussion about future events and parades and details will be announced and published as plans are solidified for these events.

**Chief of the Boat** – Rich Kunze added that it is always a lot of fun to go to Prescott the night before the 4<sup>th</sup> of July Parade and attend the rodeo.

**Base Storekeeper** – DeWayne Lober announced he has some new officers and enlisted caps for \$12.00 each. He also has dolphin stickers for the backs of cars and trucks and some shirts on sale for \$5.00 each.

**Past Commander** – Jim Denzien reported on his attendance at the Unified Arizona Veterans meeting which is conducted on the 1<sup>st</sup> Saturday of the month at state Veteran's Home. This was the last meeting before the summer break and the next meeting will be the 1<sup>st</sup> Saturday of September. A representative for the VA Medical Center announced that the Buckeye facility will be closed on at least a temporary basis because they have not been able to contract with a physician to perform services there. A state Representative by the name of Kathryn Miranda who represents District 27 addressed the group and said that there are three legislators who formed a group called the Veteran's Caucus to deal with veteran's issues in the legislature. Jim added that there are three people who are part of the Military Veteran's Commission for the City of Phoenix and they are John Altman, Melissa Lang and Howard Goldman. They are supposed to be taking over the leadership and scheduling of events for the Veteran's Day Parade. Howard Goldman said that at this time there is nothing is definitive. The VA is no longer participating as a major sponsor for the parade so we will need to rely on The City of Phoenix

and keep pushing them for an answer about the parade status. Jim announced that the Secretary of State, Ken Bennett, introduced a paver program for the WWII Memorial that will be established at Wesley Bolin Plaza. This program will be to purchase bricks with inscriptions from the donor. There will be three sizes; 4" x 8", 8" x 8" and 12" x 12". ### **Brief History of the I.S.A.**

I had the good fortune and pleasure of attending the I.S.A. (International Submariners Association) 50<sup>th</sup> Congress in Catania, Sicily this past May. (See photo, at right.) I traveled with Ken Earls, Jack Messersmith and Bill Larime who are shipmates from Gudgeon Base. (See below, right) Ken is President of the USA/ISA. Jack is Vice-President and District Commander WD1, and Bill is USA/ISA Stand-by Member at Large. Like the USSVI the ISA was formed by some WWII submarine veterans back in the 60's. Unlike the USSVI it is does not have a formal structure with elected officers, a constitution and policies & procedures. It is strictly an informal, social organization that gets together once a year in the spring somewhere in the world where one of the 24 member countries hosts the event.

The I.S.A had its first meeting when WWII French Commander Jean Blanchard and German Commander Adalbert Schnee had

the opportunity to

meet in Paris in 1962. They were both highly decorated with medals of merit. Although they fought on opposite sides, they shared their common experiences and became friends. This 1962 meeting was such a success; they arranged another meeting the following year in the same place. Admiral Parona, Commander of the Atlantic base of Italian boats in Bordeaux joined the initiative at this second meeting in the spring of 1963. The first Italian meeting was then held in Venice in 1965. From 1968 until 1996, meetings have taken place every year in rotation with the exception of 1968 and 1996.



After a few years, Austria, Great Britain and the U.S.A. joined and in recent years Russia, Poland, Chile and the Ukraine joined as well. They were followed by Israel and Argentina. The I.S.A. continues to grow and as of this year there are members from 24 countries, most of whom are submarine veterans. Other members include active duty personnel from E-3 to O-10 and membership is open to anyone with an interest in submarines.

## The Pacific!! Five things Every Sallor Should Know about the Plans for the Pacific

As the Pentagon shifts its focus to the bustling Pacific region, the Navy is weighing how to work with more countries and to manage more ships. The Navy's top officer spoke about these issues after a recent trip to the area. Here's what you need to know:

### 1. The strategy.

The Asia-Pacific region is enormous, spanning nine time zones. Planners have broken it into two regions where different kinds of warships are needed. Combatants such as cruisers, submarines and aircraft carriers will patrol the East China Sea and Sea of Japan to deter a bellicose North Korea and an assertive Chinese navy. Meanwhile, smaller ships like the littoral combat ship will focus on the Indian Ocean region, training partner navies and offering relief when needed.

"The shift to Southeast Asia: It's about forging deeper partnerships and building new ones," said Chief of Naval Operations Adm. Jon Greenert in a May 21 speech at the Center for a New American Security think tank in Washington, D.C.

### 2. Japan's new role.

One of America's closest allies in the region is assessing whether to bolster its defense by operating closer with the U.S. Navy, a vision that could have Japanese ships steaming in U.S. strike groups. "Think NATO, think U.K.," Greenert said, describing the arrangement Japanese leaders are considering.



#### 3. China cooperation.

China's naval might is felt throughout the region, including in territorial disputes. But Greenert sees plenty of chances for cooperation. For the first time, China's fleet will participate in the Rim of the Pacific exercise in 2014. And the CNO will host his Chinese counterpart, Adm. Wu Shengli, on an upcoming visit.

"We just gotta keep being persistent," Greenert said of engaging with China's navy. "I think we want the same thing: Prevention of miscalculation."

#### 4. Battle plans.

The services are developing a new strategy to counter adversaries capable of mining waters and shooting down aircraft to deny U.S. forces access.

This Air-Sea Battle concept focuses closely on joint missions between the Air Force and the Navy and is widely

believed to be the blueprint for countering China, an application officials rarely address. But it will require the U.S. military services to break down their barriers, Greenert said.

### 5. More LCSs coming.

The Navy's first LCS, Freedom, is testing Singapore as a base and logistics hub, where crews can on load mission packages and head out without spending weeks in transit to and from U.S. bases.


"We think it's the right size for Southeast Asia," Greenert said of LCS in a May 15 speech in Singapore. "And by 2020, we'll have about seven operating in and around this region."

Four are to be based in Singapore and three in Japan.

**USS Robalo (SS-273)**, a Gato-class submarine, was the only ship of the United States Navy to be named for the róbalo or common snook. Her keel was laid down on 24 October 1942 by the Manitowoc Shipbuilding Company at Manitowoc, Wisconsin. She was launched on 9 May 1943, sponsored by Mrs. E.S. Root, and commissioned on 28 September 1943.

After passage by inland waterways and being floated down the Mississippi River, Robalo deployed to the Pacific. On her first war patrol (under the leadership of Commander Stephen Ambruster, Annapolis Class of 1928), she sortied from Pearl Harbor, hunting Japanese ships west of the Philippines. There, en route to her new station in Fremantle, she damaged a large freighter, firing four torpedoes at 3,100 yards (2,800 m). She spent 36 of her 57-day mission submerged. When she arrived, her commanding officer was summarily relieved by Admiral Christie and replaced with Manning Kimmel (Class of 1935).



In March 1944, Christie (based on Ultra) feared surprise from a strong Japanese force. When Chester W. Nimitz, Jr. in USS Haddo (SS-255), made contact on his SJ radar and reported "many large ships", Christie scrambled to

respond. Robalo, along with USS Flasher (SS-249), USS Hoe (SS-258), USS Hake (SS-256), and USS Redfin (SS-272) all ran to intercept. No attack ever materialized.

For her second patrol, Robalo went to the South China Sea, assigned to interdict Japanese tanker traffic from French Indochina to the fleet anchorage at Tawi Tawi. On a "wildly aggressive patrol" lasting 51 days, Robalo fired twenty torpedoes in four attacks. She was bombed by a Japanese antisubmarine aircraft, suffering shattered and flooded periscopes and loss of radar, while taking a harrowing plunge to 350 feet (110 m) after her main induction



was improperly closed (a casualty frighteningly reminiscent of Squalus) in diving to escape. When she returned to Fremantle, Captain "Tex" McLean (commanding Subron 16) and Admiral Christie both considered relieving Robalo's skipper for his own safety. She was credited with sinking a 7500-ton tanker which was not confirmed postwar by JANAC. (NOTE: The Joint Army–Navy Assessment Committee was a United States inter-service agency set up to analyze and assess Japanese naval and merchant marine shipping losses caused by U.S. and Allied forces during World War II.)

Robalo departed Fremantle on 22 June 1944 on her third war patrol. She set a course for the South China Sea to conduct her patrol in the vicinity of the Natuna Islands. After transiting Makassar Strait and Balabac Strait (which was well-known to be mined), she was scheduled to arrive on station about 6 July and remain until dark on 2 August 1944. On 2 July, a contact report stated Robalo had sighted a Fusō-class battleship, with air cover and two destroyers for escort, just east of Borneo. No other messages were ever

received from the submarine and when she did not return from patrol, she was presumed lost.

#### **Fate of Survivors**

On 2 August, a note was dropped from the window of a cell of Puerto Princesa Prison Camp on Palawan Island in the Philippines. It was picked up by an American soldier who was on a work detail nearby. The note was in turn given to H.D. Hough, Yeoman Second Class, who was also a prisoner at the camp. On 4 August, he contacted Trinidad Mendosa, wife of guerrilla leader Dr. Mendosa who furnished further information on the survivors.



From these sources, it was concluded Robalo was sunk on 26 July 1944, 2 miles (3.2 km) off the western coast of Palawan Island from an explosion in the vicinity of her after battery, probably caused by an enemy mine. Only four men swam ashore, and made their way through the jungles to a small barrier northwest of the Puerto Princesa Prison Camp, where Japanese Military Police captured them and jailed them for guerrilla activities. On 15 August, they were evacuated by a Japanese destroyer and never heard from again. Robalo was stricken from the Naval Vessel Register on 16 September 1944.

There are two Japanese destroyers lost in August 1944 in either of which the four survivors could have been held:

- Akakaze, sunk on 23 August 1944 off Cape Bilinao (Luzon), by USS Haddo (SS-255).
- 2. Yūnagi, sunk on 25 August 1944 off northwest Luzon by USS Picuda (SS-382).

Robalo earned two battle stars for World War II service.
