Webmaster - Dan Marks

Major activity with the website since the last BOD meeting has been posting the Prescott Frontier Days® Parade photos, the Perch Base 26th Birthday, and the Holland Club Induction Ceremony. Routine updates during the past month included updating the Sailing Orders page, Flash Traffics, base correspondence and meeting minutes uploaded, Lost Boat notices and Half Staff notices posted and links updated. Similar updates have been maintained on the Perch Base Facebook Page.

During June, there were 1,437 page views on the Perch Base website during 497 sessions by 371 users based on Google Analytics. These numbers are typical. Approximately 71% of the sessions originated in the US, 7% from China, and the remainder were widely scattered around the world. Approximately 24% of the U.S. based sessions were from locations in Arizona, which is assumed to come from our membership. 52% of the traffic was to the home page, 20% to the Glossary, 3% to the Eternal Patrol page, 3% to the Sailing Orders page, and 3% to the Holland Club Induction page.

During June, the Facebook PAGE had 112 Page Views (number of times a PAGE's profile has been viewed,) 8 Page Likes (the number of new people who liked our page,) 197 Post Reach (number of people who saw any post at least once,) 95 Post Engagement (number of times people engaged with posts thru reactions, comments, shares and clicks,) and 10 Page Followers. This appears typical.
