Our Communications Officer, Chuck Luna, has been receiving bounce-backs on emails, rejected due to the Namecheap mail server "has a poor reputation on Cloudmark Sender Intelligence (CSI)." I have submitted a trouble report with Namecheap to address the problem.

Major activity with the website since the last BOD meeting has been posting Don DeMarte's Eternal Patrol Notice, adding the request for Jack Holder 100th birthday cards, the ASSM presentation to the students from South Pointe Middle School, Phoenix Veterans Day Parade photos, and the Gilbert Veterans Day Ceremony photos, Routine updates during the past month included updating the Sailing Orders page, Flash Traffics, base correspondence and meeting minutes uploaded, Lost Boat notices and Half Staff notices posted and links updated. Similar updates have been maintained on the Perch Base Facebook Page.

The annual website hosting (\$57.88) and SSL (\$29.95) renewal fees were paid during November 12, 2021. During November, there were 1,326 page views on the Perch Base website during 604 sessions by 386 users based on Google Analytics. These numbers are typical. Approximately 82% of the sessions originated in the US, 7% from China, and the remainder were widely scattered around the world. Approximately 41% of the U.S. based sessions were from locations in Arizona, which is assumed to come from our membership. 39% of the traffic was to the home page, 8% each to the Glossary and Sailing Orders pages, and 3% each to the Anthem Veterans Parade and the Phoenix Veterans Day Parade. During November, the Facebook Page Reach (The number of people who saw any content) was 488. Facebook Page Visits (The number of times your Facebook Page was visited) was 129. There was 1 New Facebook Page Like for a total of 112. The most popular post was the ASSM presentation to the South Pointe Middle School students and staff with 294 Post Reach.
