Webmaster - Dan Marks

Major activity with the website since the last BOD meeting included posting an Eternal Patrol Notice for Ed Gonsowski, an Eternal Patrol Notice was posted for Jack Patterson, posting the Eugene Crabb Eternal Patrol Notice and posting photos for the Vice Commander election. A notice was added to the "Useful Documents" page to place in member's a will or final documents to notify USSVI in the event of death. Routine updates during the past month included updating the Sailing Orders page, Flash Traffics, base correspondence and meeting minutes uploaded, Lost Boat notices and Half Staff notices posted, and links updated. Similar updates have been maintained on the Perch Base Facebook Page.

During February, there were 763 page views on the Perch Base website during 419 sessions by 324 users based on Google Analytics. These numbers are typical. Approximately 82% of the sessions originated in the US, 5% from China, 2% from Australia, and the remainder were widely scattered around the world. Approximately 29% of the U.S. based sessions were from locations in Arizona, which is assumed to come from our membership. 40% of the traffic was to the home page, 13% to the Glossary, 10% to the Sailing Orders page and 2% to the Laveen Parade photos page.

During February, the Facebook Page Views (The number of times a page has been viewed by logged-in and logged-out people) was 125. Facebook Post Reaches (The number of people who saw any posts at least once) was 531. There were 251 Facebook Post Engagements (the number of times people engaged with our posts through reactions, comments, shares, and clicks) There were 3 New Facebook Page Likes for a total of 119. Similar to the website, these numbers are typical. The most popular post was the Vice Commander election posting with 127 Post Reach.
